- b) Any other appropriate mode of interaction agreed upon between CMRJ and SSJGC, Sirsa. A specific plan will be worked out by both the institutes depending upon availability of resources.

### 4. Terms and conditions

- a) The cost of development of infrastructure should be borne by the concerned institute.
- b) For education and research, the financial arrangements will be made on the basis of mutually agreed terms by both institutes.
- c) Usage of academic infrastructure of CMRJ and SSJGC, Sirsa can be allowed for limited period only subject to its availability and mutual consent.
- d) Both institutes agree to help, identify and invite the faculty members and girls students from the other institutes to participate in conferences, workshops and short-term courses.
- e) Both institutes can modify/delete/add any field of cooperation not mentioned in this MoU by mutual consent at any time in future.
